This *US Speedskating* sanctioned event will be raced on a 111m track on one of the rink's two 200' x 85' sheets of ice. Skaters aged 6 and under will race on an 85m track. This competition will be held in a championship format. Each skater will race a semifinal and a final in two distances for a total of four races. Race heats will be organized by ability. Award divisions are based on age and gender.

ELIGIBILITY:

Skaters of all abilities, ages, and from all countries are welcome. All skaters must be active members in good standing with US Speedskating or with their country's NGB (National Governing Body). A valid NGB member number must be entered on this entry form and will be verified. All skaters will automatically be entered into all eligible races. At least one seed time must be provided to organize safe and fair races. **Skaters that do not have a seed time will be placed in novice groups.**

RACE/AWARD FORMAT:

Each competitor will race a semifinal and a final in two distances for a total of four races. Racers will be placed in divisions according to their ages and races will be heated according to their ability determined by entry seed times. Event officials may reorganize heats in the interest of safety. Awards will be given according to points totals in each gender and age division.

SAFETY EQUIPMENT:

To assure skater safety, comply with US and International rules, and to prepare skaters for higher levels of competition, PSSC has adopted rules regarding safety equipment that are based on US Speedskating's *Rules for Competition* and *ISU Communication 2636 Protection Equipment in Speed Skating and Short Track Speed Skating*. During equipment check, every skater will be required to show that they have the required safety equipment and that their front and rear skate tips are rounded to at least 1 cm.
